Activity Title: At WHO's request, collect and collate data to inform mapping on the use of traditional medicine among Indigenous Peoples (i.e., national minorities) in the Nordic countries.

Description: As per WHO's request, the institution will collect and collate information for WHO's consideration on mapping the use of traditional medicine among Indigenous Peoples (i.e., national minorities) in select Nordic countries as identified by WHO. Data will be collected through qualitative research literature review and by gathering expertise and experiences from relevant stakeholders as identified by WHO. The institution will analyse and summarize the data.

Activity Title: On WHO's request, provide technical input that may inform WHO's work towards expanding medication safety and quality of care in TCI.

Description: The Institution will provide technical inputs to WHO, as and when requested by WHO, that may inform its work in the process of preparing any relevant publication or technical product on safety of TCI modalities and quality of care package in TCI.

Activity report: WHO global traditional medicine strategy (2025–2034)

Upon request by WHO, NAFKAM reviewed the draft strategy on several occasions and repeatedly provided input. April 2024: public consultation on draft strategy, review by NAFKAM (Miek Jong and Barbara Wider), request from WHO. June/July 2024: EURO regional consultation, review and online meeting, request from WHO.

September 2024: global Member States consultation, review of draft strategy, request from WHO to Norwegian Ministry of Health and Care Services.

Activity ID: A-24027

Activity Title: At WHO's request, provide technical support to WHO that may inform its work on evaluating the impact of WHO TCI benchmarks in acupuncture.

Description: Under WHO's guidance, the institution will collaborate with other WHOCCs of the TCI network to develop a protocol for surveying end users' perspectives of WHO training and practice benchmarks in TCI, and pilot it for the benchmarks

in acupuncture (WHO benchmarks for the practice of acupuncture and WHO benchmarks for the training of acupuncture, 2021). The institution will collate the information gathered from the pilot study, analyse it and present to WHO with technical inputs which may be used by WHO to inform WHO's work on evaluating the impact of WHO benchmarks.

Status: Ongoing

Activity report: In collaboration with WHOCCs Royal London Hospital of Integrative Medicine and Korea Institute of Oriental Medicine, NAFKAM had developed a proposal to assess practitioners' perceptions of WHO benchmarks on the training and practice of acupuncture.

NAFKAM resubmitted the proposal to WHO on 24th April 2024 and asked WHO for an online meeting to provide guidance in compliance with the Terms of Reference: "WHO will identify the type of inputs required as well as provide criteria for data collection and analysis as well as providing guidance to the Institution at all stages of this activity and reviewing and validating the information collated and technical inputs and ensure their alignment with WHO's norms, rules, policies, and standards."

NAFKAM has not yet received a response from WHO but is awaiting guidance from WHO before proceeding with this activity.
